That I am 18 years of age or older or this Release is signed by my parent or guardian. 5. That any photographs, pictures, slides and/or movies of me taken or made by the Released Parties in connection with the Event, or any reproduction of the same, as well as my name, may in any manner be used by Released Parties, or by any person, corporation, partnership or association authorized by Released Parties. 6.
